Invitation of public comments

**Sub: Proposal of grant of access permission to the proposed retail outlet of M/s. Essar Oil Ltd in Km No.79+792 to 79+827 RHS on NH-89 (New NH-58) in Khasra No. 959/639 of Village-Lanchha ki Dhani, Taluka-Merta & District-Nagaur in the state of Rajasthan.**

M/s BPCL ie. the applicant vide letter even dated 08.06.2017 has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. There is an intersection on opposite side at a distance of 20 m of the proposed outlet which has been agreed by EE(NH) PWD Nagaur in his inspection report submitted to this office vide even letter dated 18.05.2018 . However the proposed retail outlet proposal is submitted in this office through service of 5.5m wide and 240m long as per the proposed drawing which will be constructed and maintained by oil company and special undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per Form A (copy enclosed) on below mentioned address.
