Sub: Permission for laying 26" Dia (660mm) Crude Oil Pipeline along with Optical Fibre Cable through HAB Method across NH-15 at Km 219+035, Km 247+495 & Km 253+905 for the proposed Paradip-Siliguri-Numaligarh Crude Oil Pipeline Project-Reg.

The DGM(P), PMU Tezpur vide its letter no.: 230001/OFC/NHIDCL/Tez/15634 dated 14.07.2022 (proposal in hard copy received on 16.07.2022) has submitted a proposal alongwith recommendation for accord of permission for laying 26" Dia (660mm) Crude Oil Pipeline along with Optical Fibre Cable through HAB Method across NH-15 at Km 219+035, Km 247+495 & Km 253+905 for the proposed Paradip-Siliguri-Numaligarh Crude Oil Pipeline Project.
