Invitation of Public Comments

Sub: Four Laning of Demow (Km 534+800) to End of Moran Bypass (Km 561+700) of NH-37 including Emergency Landing Facility (ELF) in the state of Assam on EPC Mode- **Request for permission for crossing of National Highway 37 at Chainage 537.665 km in between Demow and Moran by 8" (200 mm) Crude Oil Transportation Pipeline between Well Head Setup - MFJ to MRN-109 via Well Head Setup - MFK at Pipeline Chainage 11.126 km form Well Head Setup MFJ- Reg.**

The DGM (P), PMU-Dibrugarh vide letter NHIDCL/PMU-DBRG/UtilityCrossing/NH-37/537.665/2023/276 dated 14.02.2023 has submitted a proposal along with recommendation for according ROW Permission for laying of 8" (200 mm) Crude Oil Transportation Pipeline between Well Head Setup - MFJ to MRN-109 via Well Head Setup - MFK at Pipeline Chainage 11.126 km form Well Head Setup MFJ in between Demow and Moran through Horizontal Boring Method across NH-37 at Chainage 537.665. The applicant, Oil India Limited had submitted their proposal to the PMU vide their letter no WA/1-26/03/2023 dated 08.01.2022. The DGM(P), PMU-Dibrugarh has certified the proposals, checklist and drawings as per the extant practice.

2. The subject cited NH Section is presently under construction and is being developed to a 4 Lane facility.
3. As per Ministry's circular no.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent modification dated 15.01.2021, the Highway administrator will make available the subject proposal on the portal for 30 days seeking for public comments on ground of public interest.
4. In view of the above, the comments of the public are invited on the captioned proposal and the same should reach the below mentioned address till 30 (thirty) days from the date of public interest.
