### Invitation of public comments

**Sub.: Proposal for final formal permission and signing of license deed for access to the proposed fuel station of M/s IOCL on NH-76 (New NH No.35) at Km.358.422 (LHS), Village Garha (Katra), Tehsil Bara & District Allahabad in the State of Uttar Pradesh – Time Extension – Reg.**

1. The instant proposal was granted provisional NOC vide this office vide letter no. RO/LKO/HA/NH-76(35)/17/2013/129 dated 22.01.2015. As per para-3 of the same "In case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority". However, it is seen that the proposal has been submitted to this office after 2 years from the date of issue of provision NOC. In this regard, Chief Engineer (NH), UP PWD, Lucknow vide letter dated 09.03.2018 has submitted justification for the delay in construction of the instant retail outlet, enclosing therewith format for relaxation in light of the deviation from the extant guidelines.

2. The Oil Company M/s IOCL has sought relaxation for the above mentioned deviation on the following ground:

(i) As the DM NOC was granted to M/s IOCL on dated 21.05.2017 and received by M/s IOCL on 06.06.2017, therefore, the Oil Company could not start the work immediately on the project in absence of these statutory approval as budget is approved only when all the statutory approvals are in hand.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
