Invitation of public comments

Sub.: Proposal for final formal permission and signing of license deed for access to the fuel station of M/s HPCL on NH-93, Km. 22.734, LHS on Khasra no. 1186 at Village - Kursanda, Tehsil - Sadabad District - Hathras in the State of Uttar Pradesh – Time Extension - Reg.

1. The provisional NOC for the instant retail outlet was approved 'in-principle' by competent authority in the Ministry vide letter no. NH-12017/59/2011/UP/NH-II dated 27.07.2012 with the condition that "in case the proposal for grant of final permission and signing of License Deed are not received within one year of grant of provisional NOC, the same shall be treated as cancelled and provisional NOC granted by the Ministry be treated as withdrawn". However, it is seen that the proposal has been submitted to this office after the lapse of the stipulated deadline.

2. The Regional Officer (CGM), UP-West, NHAI, Lucknow, vide letter no. 19001/1/RO-W-UP/NH-93/NOC/1778 dated 09.12.2017 has reported that the retail outlet has been completed as per provisional NOC. However, it is seen that the application has been submitted after 5 years from the date of issue of provisional NOC. Thus, the relaxation is required for the aforementioned deviation for issue of final formal permission.

3. The applicant M/s HPCL has sought relaxation for the above mentioned deviation on the following ground:

(i) Forest NOC for the retail outlet of M/s HPCL at Km.23 was received on 28.09.2016. On receipt of forest NOC, construction was then started and all jobs was completed in month of April 2017.

4. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
