Invitation of Public Comments

Sub: Permission for laying of 16" dia (Carbon Steel Pipe) Tundla-Gawaria product pipeline across NH-2/ NH-19 (Agra - Kanpur) in Sitauli Village of Etamadpur, Distt.-Agra in the State of UP.

The Chief Construction Manager, M/s Indian Oil Corporation Limited has submitted the proposal for permission for laying of 16" dia (Carbon Steel Pipe) Tundla-Gawaria product pipeline across NH-2/ NH-19 (Agra - Kanpur) at Ch. 218.967 in Sitauli Village of Etamadpur, Distt.-Agra in the state of Uttar Pradesh.

2. From the submitted proposal, it is seen that the crossing length is proposed 63.00m. Left side from center line towards increasing chainage/ km direction is 34m and Right side from center line towards increasing chainage/ km direction is 29m. Diameter of the Pipeline/ Cable is 16" Carbon Steel Pipeline. Further, the minimum depth of Pipeline below the ROW will be 7.0m. At the centre line of road the pipeline will be at a depth of 8.96m from the ground level.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/ 2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.


