Invitation of Public Comments

Sub: Proposal for NOC permission for laying of Water pipeline with road crossing on NH-25 (New NH-27) Jhansi-Orai Section at Chainage 122.685 to 122.800 km, RHS) near Parichha, District-Jhansi in the State of Uttar Pradesh - reg.

The Executive Engineer, Construction Division, U.P. Jal Nigam, Jhansi has submitted the proposal through PD, PIU-Jhansi for NOC permission for laying of Water pipeline with road crossing on NH-25 (New NH-27) Jhansi-Orai Section at Chainage 122.685 to 122.800 km, RHS) near Parichha, District-Jhansi in the State of Uttar Pradesh.

- 2. From the submitted proposal, it is seen that as per checklist, the Water Pipe Line is proposed in utility corridor within NH ROW. Proposed length is 115mtr. from Chainage 122.685 to 122.800 km. along Right Hand Side. Width of available ROW is 38m. Left side from centre line towards increasing Chainage/ km direction is 19.00m. and Right side from centre line towards increasing Chainage/ km direction 19.00m. Road crossing is proposed at Ch. 122.685 by Trenchless method. Laying work will be carried out through Horizontal Directional Drilling (HDD) method along NH. The existing NH is 4-lane divide carriageway.
- 3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained
