### Invitation of Public Comments

**Sub:** Proposal for NOC permission for laying of TGPL Underground Gas Pipe of 8" Dia (200mm) Carbon Steel Pipeline from km. 168.300 to km. 174.900 (Dilari to Munda Pande) towards (Lucknow Road) and Crossing at two locations at ch. 166.200 & ch. 144.300 under NH-9 (Old NH-24) Laxmipur Katai Near Gopalji Filling Stating and Dhanupura Village Near (CNG Station on NH-9 (Old NH-24) in the State of Uttar Pradesh.

The Manager Projects M/s Torrent Gas Pvt. Ltd. (TGPL), Moradabad has submitted the proposal through PD, PIU-Moradabad for NOC permission for laying of TGPL Underground Gas Pipe of 8" Dia (200mm) Carbon Steel Pipeline from km. 168.300 to km. 174.900 (Dilari to Munda Pande) towards (Lucknow) and Crossing at two locations at Ch. 166.200 & Ch. 144.300 under NH-9 (Old NH-24) near Laxmipur Kattai Near Gopalji Filling Stating and Dhanupura Village Near (CNG Station on NH-9 (Old NH-24) in the State of Uttar Pradesh.

2. From the submitted proposal, it is seen that as per checklist, the Gas Pipe Line is proposed in utility corridor within NH ROW. Proposed length is 6.6km. approx. from km. 168.300 to km. 174.900 (Dilari to Munda Pande) along Left Hand Side and two crossing at two locations at Ch. 166.200 & Ch. 144.300. Width of available ROW is 22.5-30m from centre of highway. Left side from centre line towards increasing Chainage/ km direction is 22.5-30m. and Right side from centre line towards increasing Chainage/ km direction 22.5-30m. Laying/crossing work will be carried out through Horizontal Directional Drilling (HDD) method only. Top of the pipe line will be laid at least 1.2 meters below the natural ground level and trench width approx. 0.6 meter. The existing NH is 4-lane divided carriageway.

3. As per the guidelines issued by the Ministry vide OM No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).


