These schemes collectively focus on capacity building, enforcement support, behavioural change, and reduction in road accidents and fatalities:

- ii. Setting up of Inspection and Certification Centres (I&C)
- iii. Financial Assistance to NGOs for Road Safety Advocacy Programmes and Publicity Measures and Awareness Campaigns on Road Safety
- iv. Rah-Veer (formerly Good Samaritan Scheme)
- v. Electronic Detailed Accident Report (e-DAR)
- vi. Workshop cum Training Programme for development of Human Resources in States'/UTs'
- vii. Central Assistance for strengthening the ITS in Public Transport System in the Country.
- viii. Development, Customization, Deployment and Management of State-wise Vehicle Tracking Platform for Safety& enforcement with AIS 140 specification and other projects.
- ix. Cashless treatment of Road Accident Victims, Scheme- 2025

2. The current 15th FC Cycle of Central Sector Schemes have entered the terminal year and is going to ends on 31st March, 2026. Department of Expenditure, Ministry of Finance vide their OM dated 5.5.2025 has informed the schemes to be continued over the next FC cycle will undergo fresh appraisal and approval process. Each such scheme has to first undergo an outcome review in the form of a Third-Party Evaluation.

3. For this purpose, National Productivity Council, under Department for Promotion of Industry & Internal Trade (DPIIT), Ministry of Commerce & Industry, Govt. of India has been entrusted the task for evaluation of Transport Division

Schemes of this Ministry. The entire process is time bound and report is required to be forwarded to Ministry of Finance along with necessary appraisal memo.

4. The study would focus on obtaining of Primary, Secondary data on the projects implemented under these Schemes. Further, the study team of NPC would also interact with all concerned stakeholders associated with the implementation of these schemes including beneficiaries. Field study would be done through structured questionnaire, and physical check-ups (if any) on pan India basis for the projects implemented from financial assistance under these Scheme

Your esteemed organization, being the stakeholder in implementation of these Schemes, is requested to provide all assistance to the study team, make the data/information pertaining to implementation of the schemes available and arrange stakeholder consultation/ meeting during the field visit.
