Invitation of public comments

Sub.: Proposal for provisional NOC for access road permission to the proposed retail outlet of M/s Indian Oil Corporation Limited between Km.64 & Km.65 (Ch.64.066) on NH-74 (New NH-30) at present NH-74 at km.318 (Ch.318.643, RHS), Village - Sithra, Tehsil - Nawabganj & District - Bareilly in the State of Uttar Pradesh - Reg.

The Regional Officer, UP-West, NHAI, Lucknow vide letter no. 14001/1/RO-W-UP/NH-74/NOC/6390 dated 30.03.2019, for issue of provisional NOC for access road permission to the proposed fuel station mentioned in subject.

2. From the submitted location plan, it is seen that two roads, one Chak Marg is adjacent to the fuel station and one kharanja road at a distance of 288m from the proposed retail outlet are existing as against the minimum requirement of 300m, as per para 4.5.1 (ii) of Ministry's guidelines dated 24.07.2013.

2.1 The Oil Company has requested for relaxation in view of para 2 above. The reasons for relaxation as recommended by Project Director, PIU, NHAI, Bareilly are as follows:

(i) There is a below 3m wide Chak Marg adjacent of proposed site, which is terminated at field. Further, it is observed that there is no traffic movement on this chak marg. Villagers informed that chak marg is used occasionally when crops time only.

(ii) There is 2.4m wide kharanga road at a distance of 288m from proposed site, which goes to door to door of houses and terminated at field. It is observed that there is no traffic found on this kharanja road.

(iii) Hence, approach of proposed site will not hinder to NH traffic or not effect to road safety.


