

Invitation of public comments

Sub.: Proposal for final formal permission and signing of license deed for access to the proposed fuel station of M/s IOCL on NH-24 (New NH No.30) at Km.433 (Ch.432.271, LHS), Village - Daudhapur, Tehsil – Sidhauli & District – Sitapur in the State of Uttar Pradesh – Time Extension – Reg.

1. The instant proposal was granted provisional NOC by Ministry vide letter no. NH-12017/17/2013/UP/NH-II dated 15.10.2013. As per para-2 of the same "In case the proposal for grant of final permission and signing of license deed are not received within one year of grant of provisional NOC, the same shall be treated as cancelled and provisional NOC granted by the Ministry be treated as withdrawn". However, it is seen that the proposal has been submitted to this office after 4 years 5 months from the date of issue of provisional NOC. In this regard, Regional Officer (CGM), UP-East, NHAI, Lucknow vide letter dated 09.03.2018 has submitted justification for the delay in construction of the instant retail outlet, enclosing therewith format for relaxation in light of the deviation from the extant guidelines.

2. The Oil Company M/s IOCL has sought relaxation for the above mentioned deviation on the following ground:

(i) As the DM NOC was granted to M/s IOCL on 04.01.2015 and from Chief Fire Office was granted vide letter dated 16.08.2015, thus M/s IOCL could not start the work immediately on the project in absence of these statutory approval as budget is approved only when all the statutory approvals are in hand.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
