The Regional Officer (CGM), UP-West, NHAI, Lucknow vide letter no. 19001/1/RO-W-UP/NH-91/NOC/ 2404 dated 20.03.2018 has submitted a proposal for access permission with respect of fuel station mentioned in the subject above.

2. From the submitted location plan, it is seen that there are two katcha roads a distance of 175.10m and another at a distance of 11.70m from the proposed retail outlet as against the minimum requirement of 300m, as per para 4.5.1 (ii) of Ministry's guidelines dated 24.07.2013.

2.1 The Oil Company has requested for relaxation in view of para 2 above. The reasons for relaxation as recommended by Project Director, PIU, NHAI, Aligarh are as follows:

(i) Applicant has proposed to construct a 7m wide and 750m long service road including deceleration/acceleration lane with separator which is covering intersections.

(ii) Both Earthen tracks (chak marg) terminate at field.

(iii) Only cyclists/motor cyclists & pedestrians use these earthen tracks, no LMV/heavy vehicles ply on these earthen tracks. Therefore, there is minimum traffic on these roads without disturbing NH traffic.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
