Invitation of Public Comments

Sub: Permission for erection/installation of LILO of 132KV Sardhana-Kankarkhera-II @ Modipuram-II Transmission line for Overhead crossing on NH-334B (Meerut-Baghpat) between Ch. No. 6+500 & 6+525 near village-Janee Khurd, district-Meerut in the State of Uttar Pradesh- reg.

The Executive Engineer, Electricity Transmission Division, UPPTCL, Meerut has submitted the proposal through Project Director, Baghpat for the permission of erection/installation of LILO of 132KV Sardhana-Kankarkhera-II @ Modipuram-II Transmission line for Overhead crossing on NH-334B (Meerut-Baghpat) between Ch. No. 6+500 & 6+525 near village-Janee Khurd, district-Meerut in the State of Uttar Pradesh.

2. From the submitted proposal, it is seen that structures (Transmission Towers) on either side are being erected at distance of 90m & 103m respectively from either side of NH boundary. Crossing span of the structure is 217m. Further, the minimum vertical clearance of 19.80m between the lowest conductor of the proposed line and NH carriageway shall be maintained. However, the proposed transmission line shall be crossing the National Highway at 81^o angle.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.
