<u>Sub</u>: Proposal for permission for laying proposed 10"/8" Natural Gas Pipeline with OFC along/across NH-30 (Old NH-24) via Rampur Town from Mansurpur to Faizulla Nagar from km. 181.130 to km. 189.080 & One crossing at Ch. 184.870 in District-Rampur in the State of Uttar Pradesh.

The General Manager-Projects M/s HPCL, CGD, UP Cluster-Bareilly has submitted the aforesaid proposal for permission for laying proposed 10"/8" Natural Gas Pipeline with OFC along/across NH-30 (Old NH-24) via Rampur Town from Mansurpur to Faizulla Nagar from km. 181.130 to km. 189.080 & One crossing at Ch. 184.870 in District-Rampur in the State of Uttar Pradesh.

2. From the submitted proposal, it is seen that as per checklist the Natural Gas Pipeline is proposed from km. 181.130 to km. 189.080 (length= 7950m) & One crossing at Ch. 184.870 (45m) (Total proposed length= 7995m) along/across NH-09 (Old NH-24). Width of available ROW 45m. The NH is existing 2 lane. Applicant has proposes Methodology for laying/crossing of Gas Pipeline through open trench Method only. However, permission will be given through open trench for the work executing along the Highway only with the condition that embankment of the Highway should not be damaged and laying will be done at the edge of ROW. Further, while laying of pipeline along the Highway, if there is a cross road/approach road connecting Highway, then at that particular location laying will be done only through HDD Method. In case of crossings, work should be executed strictly through HDD method.

3. As per the guidelines issued by the Ministry vide OM No.RW/NH-33044/29/ 2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).


