Invitation of Public Comments

Sub: NHAI, RO, Chennai – PIU, Villupuram – Requesting permission for laying of Water Pipeline in the project stretch of NH-81 (Trichy to Kallagam Section) Service Road of Fly Over Area, along the road from Km.0/50 to Km.0/150 (LHS) and from Km.0/000 to Km.0/850 (RHS) for a total length of 950m - Approval requested – Reg.

Ref: The Executive Engineer, TWAD Board Maintenance Division, Trichy Lr No. 131225/ F.WSS To Samayapuram Temple/2025 dated 13.12.2025 received on 17.12.2025.

1. The subject proposal is requesting permission for laying of water pipeline in service road of fly over area, along the road from Km.0/50 to Km.0/150 (LHS) and from Km.0/000 to Km.0/850 (RHS) for a total length of 950m in the project stretch of NH-81 (Trichy to Kallagam Section) in the State of Tamil Nadu.
2. The Executive Engineer, TWAD Board Maintenance Division, Trichy has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board Maintenance Division, Trichy will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.


