Invitation of Public Comments

Sub: NHAI, PIU, Viluppuram - Four laning and strengthening of existing two lane from Tindivanam to Ulundurpet section Km.121/000 to Km.192/250 of NH45 - Proposal for laying of Sewerage pipeline on NH-45 along the road from Km.121/000 to Km.121/200 (RHS) with Manhole (2m x 2m) @ 30m spacing for a total length of 200m along the NH by M/s. TWAD Board, RWS Division, Viluppuram - reg.

1. The subject proposal is requesting a permission to lay a sewerage pipeline along the NH-45 by open excavation of 150mm & 350mm dia CI pipe (Pumping main) & 200mm dia UPVC pipe (Sewer line) from Km.121/000 to Km.121/200 (RHS) with Manhole (2m x 2m) @ 30m spacing for a total length of 200m along the NH by M/s. TWAD Board, RWS Division, Viluppuram in the project stretch of Tindivanam to Ulundurpet section of NH45.

2. M/s. TWAD Board, RWS Division, Viluppuram had given an undertaking to shift the utility line for any work of improvement or repairs to the road, If NHAI considers it as necessary, in the future, it will be carried out as desired by the NHAI at the cost of the applicant within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking to pay rent/fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R Dt.22.11.2016 as and when asked by NHAI.

3. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) Dt.22.11.2016, the proposal submitted by M/s. TWAD Board, RWS Division, Viluppuram will be put out in the Ministry's website for 30 days seeking Claims/Comments/Objections (on ground of public inconvenience, safety, and general public interest) from the day of disclosure in the website.
