- 1. The subject proposal is requesting a permission to lay an underground sewerage pipeline of 400mm Dia MS Casting pipe is to be laid across the road at Km.38/800, Km.39/230 & Km.41/280 of NH-66 for carrying the sewerage pipeline with a depth of 2m below top of the Subgrade level by HDD method in the project stretch of Tindivanam to Krishnagiri section of NH-66 in the state of Tamilnadu.
- 2. M/s. TWAD Board, RWS Division, Viluppuram had given an undertaking to shift the utility line for any work of improvement or repairs to the road, If NHAI considers it as necessary, in the future, it will be carried out as desired by the NHAI at the cost of the applicant within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking to pay rent/fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R Dt.22.11.2016 as and when asked by NHAI.
