
1. The subject proposal is requesting permission for Erection of 7-MV Overhead Electrical Transmission HT Line AL-59 Panther Conductor Power Cables Line (2 Nos) and 45m C/C Interval Poles (55 Nos) - along the RoW from Km.146/637 to Km.149/292 [RHS] and across the road HT Line with Tower at Km. 146/637 & Km.149/292 in Tindivanam to Ulundurpet Section of NH-45 in the State of Tamil Nadu.
2. M/s. Eternal Renewables Private Limited, Coimbatore has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Eternal Renewables Private Limited, Coimbatore will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
