M/s. Jio Digital Fibre Private Ltd. vide letter cited above has submitted proposal for laying/Crossing underground OFC cable along ROW of NH-3 (Dhule-Pimpalgaon) Section of NH-3 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the laying/Crossing underground OFC cable using HDD Method is proposed along ROW of NH-3 (Dhule-Pimpalgaon) Section from Km. 310.800 to Km. 311.380 (RHS & LHS) Total Length 1.16 Km. & 2 crossings at Km. 310.800 & Km. 311.380 on NH-3.
- As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
