Sub: NHAI-PIU-NSK- Six Laning of Pimpalgaon-Nashik-Gonde section of NH-3 from Km 380.000 to 440.000 in the State of Maharashtra - Maharashtra Natural Gas Limited's (MNGL) Proposal for laying Gas Pipeline from Km. 411.382 to Km. 409.200 (LHS) and Km. 409.200 to Km. 406.100 (RHS), Total length- 5.282 Km & 2 Crossing at Km. 409.200 & Km. 406.100 on NH-3.

Maharashtra Natural Gas Limited's (MNGL) vide letter cited above has submitted Proposal for laying /crossing Gas Pipeline along/across ROW of NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying / crossing Gas Pipeline is proposed along NHAI ROW from Km. 411.382 to Km. 409.200 (LHS) and Km. 409.200 to Km. 406.100 (RHS), Total length- 5.282 Km & 2 Crossing at Km. 409.200 & Km. 406.100 on NH-3.

As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
