**Sub:** NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for Vadape-Gonde (Km 539.500-Km 440.000) section of NH-3 in the State of Maharashtra - M/s. Torrent Power Ltd.'s Proposal for laying 22KV HT Cable from Km. 529.476 to Km. 532.500 Total Length 3.024 Km. (LHS) on NH-3- Reg.

M/s. Torrent Power Ltd.'s vide letter cited above has submitted proposal for laying underground 22Kv HT Cable along ROW of NH-3 (Vadape-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.
