Sub: NHAI-PIU-NSK- Four laning of Sinnar - Shirdi Section of NH 160 from Design Ch:0/000 to 50/943 including Sinnar Bypass of 3.375 km and Resurfacing of existing Road from existing Ch: 57/500 to 62/800 in the State of Maharashtra - Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL) Proposal for laying 11 KV HT Line by Aerial Method on RSJ Poles from Km. 7+200 to Km. 11+150 (RHS) on NH-160.

Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL), Rural Division, Nashik vide letter cited above has submitted Proposal for laying 11 KV HT Line on RSJ Poles along ROW of NH-160 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying of Electric Line is proposed along NHAI ROW from Km. 7+200 to Km. 11+150 (RHS) on NH-160, Total length- 3.950 Km on Sinnar-Shirdi section of NH-160.

As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
