Nashik Municipal Corporation (NMC)'s vide letter cited above has submitted proposal for laying Water Pipeline along ROW of NH-3 (Pimpalgaon-Nashik-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.
