M/s. Tata Teleservices (Maharashtra) Ltd.'s Mumbai vide letter cited above, has submitted the Proposal for laying 400 m laying of OFC along NH-3 (Pimpalgaon-Nashik-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.
