(DIT Mantralaya) proposal for laying Telecom OFC in stretches from Km. 471.300 to Km. 539.500 (LHS & RHS) (Length 47.90 Km & 15 Crossings) on NH-3 - Reg.

Maharashtra Information Technology Corporation Ltd. (DIT Mantralaya) vide letter cited above, has submitted the proposal for laying underground OFC cable along ROW of NH-3 (Vadape-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying underground OFC cable is proposed along ROW of NH-3 (Vadape-Gonde) Section from Km. 471.300 to Km. 539.500 (Length 47.90 Km & 15 Crossings).
