Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for Vadape-Gonde (Km 539.500-Km 440.000) section of NH-3 in the State of Maharashtra Maharashtra Jeevan Pradhikaran (MJP) under Scheme of Jal Jeevan Mission Proposal for laying Water Pipeline from Igatpuri to Shahapur, Total length- 60.72 Km & Crossing 13 Nos. on NH-3- Reg.
