Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for **Vadape - Gonde** (Km 539.5-Km 440) section of NH-3 in the State of Maharashtra - **M/s. Mumbai Urja Marg Ltd.'s Proposal for Overhead Crossing of 400 KV D/C Transmission Line at Km. 524.190 on NH-3.**

M/s. Mumbai Urja Marg Ltd.'s vide letter cited above has submitted Proposal for Overhead Crossing of 400 KV D/C Transmission Line along/across ROW of NH-3 for approval of the Competent Authority, Highway Administration.
