Sub: NHAI-PIU-NSK-Four laning of Sinnar to Shirdi Section of NH 160 from Design Ch:0/000 to Ch:50/943 including Sinnar Bypass of 3.375 km in the State of Maharashtra on Hybrid Annuity Mode - Maharashtra State Electricity Transmission Company Ltd.'s (MSETCL) Proposal for Overhead Tower Crossing between Km. 39.860 and Km. 39.870 across Sinnar-Shirdi Section of NH-160.

Maharashtra State Electricity Transmission Company Ltd.'s (MSETCL) vide letter cited above, has submitted the Proposal for Overhead Tower Crossing across NH-160 (Sinnar-Shirdi) Section for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Overhead Tower Crossing is proposed across NH-160 (Sinnar-Shirdi) Section between Km. 39.860 and Km. 39.870.
