Executive Engineer, MIDC, Ambernath Civil Dn., Ambernath vide letter cited above has submitted proposal for Water Supply Pipeline along & across ROW of NH-3 (Vadape-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.
