Km. 282.800, Km. 286.000 & Km. 298.600 across NH-3.

Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL), Rural Division, Dhule vide letter cited above has submitted Proposal for Crossing 11 KV Electrical Line across NH-3 for approval of the Competent Authority, Highway Administration.
