Sub: NHAI - PIU, Salem - Proposal for laying of a Public Utility - "City Gas Distribution (CGD): Carbon Steel and MDPE Pipelines with OFC along NH-44 (Sri Nagar - Kanyakumari Highway) in between highway of increasing Chainage Km 207/650 to Km 210/100 (LHS) by M/s Indian Oil Corporation Limited, Salem - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of underground 4.5" Dia Carbon Steel and MDPE Pipelines with Optical Fiber Cable (OFC) along the NH-44 by HDD Method from Km 207/650 to Km 210/100 (LHS) in the project of Thumbipadi - Namakkal section of NH-7 in the State of Tamil Nadu.
- 2). M/s Indian Oil Corporation Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
