- 1). The subject proposal is requesting permission for laying of underground 4.5" Dia Carbon Steel and MDPE Pipelines with Optical Fiber Cable (OFC) along the NH-44 by HDD Method from Km 207/650 to Km 210/100 (LHS) in the project of Thumbipadi - Namakkal section of NH-7 in the State of Tamil Nadu.
- 2). M/s Indian Oil Corporation Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given.
