Sub: NHAI, Madurai Region - PIU, Nagercoil - Permission for laying water supply pipeline along NH from Km 0/000 to Km 0/400 (RHS) in Nagercoil - Kavalkinaru section of NH-47B, and crossing at Km 0/000 of NH-47B) (i.e. Km 82/000 in Villukuri to Kanyakumari section of NH-47) in the State of Tamil Nadu - Proposal submitted - Reg

The proposal is regarding permission for laying water supply pipeline along NH from Km 0/000 to Km 0/400 (RHS) in Nagercoil - Kavalkinaru section of NH-47B, and crossing at Km 0/000 of NH-47B) (i.e. Km 82/000 of NH-47) in the State of Tamil Nadu i.e. in a length of 400 m was submitted to this office by PD, PIU Nagercoil vide letter No. NHAI/PD/PIU/NGL/NH-47/NOC/2020/183 dated 05.02.2020 (received on 08.02.2020) in accordance with Ministry's latest guidelines dated 22.11.2016.

The alignment proposed by the Executive Engineer, TWAD, Project Division, Nagercoil, for laying water supply pipeline along NH from Km 0/000 to Km 0/400 (RHS) in Nagercoil - Kavalkinaru section of NH-47B, and crossing at Km 0/000 of NH-47B) (i.e. Km 82/000 of NH-47) in the State of Tamil Nadu i.e. in a length of 400 m as detailed under:

3. The right of way is 60m in the aforesaid stretch. The Executive Engineer, TWAD, Projects Division, Nagercoil, has proposed to lay water pipe line at the extreme edge of the ROW for a length of 400 m. The laying of water supply pipe line is proposed to be laid at a distance 29 m from the center line of the carriageway

which is in conformity with Ministry's guidelines vide letter no. NHIII/ P/ 66/76 dated 19.11.1976. Further, the Executive Engineer, TWAD, Projects Division, Nagercoil has given undertaking that the lay of water pipe line is proposed to lay by *Open Trench Method* for a distance of 29 m from the center line of the carriageway and Across at Km 0/000 of NH-47B (i.e. Km 82/000 of NH-47) by *HDD Method* at a depth of 1.2 m from the bottom of the ground which is in conformity with Ministry's guidelines vide letter no. NHIII/ P/ 66/76 dated 19.11.1976.

- 4. The Executive Engineer, TWAD, Projects Division, Nagercoil has furnished an undertaking to the effect that they will remove the laid of water pipeline in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipe line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
- 5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R (R) dated 22.11.2016 the relaxation application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
