NHAI-PIU-NSK- Six Laning of Pimpalgaon-Nashik-Gonde section of NH-3 from Km 380.000 to Sub: 440.000 in the State of Maharashtra - Maharashtra Natural Gas Limited (MNGL) Proposal for laying Gas Pipeline from Km. 425.520 to Km. 440.000 (RHS) on NH-3, Total length- 14.480 Km & Crossing at Km. 440 - Reg.

Maharashtra Natural Gas Limited (MNGL) vide letter cited above has submitted Proposal for laying / crossing Gas Pipeline along / across ROW of NH-3 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the laying / crossing Gas Pipeline is proposed along NHAI ROW from Km. 425.520 to Km. 440.000 (RHS) on NH-3, Total length- 14.480 Km & Crossing at Km. 440 on Pimpalgaon-Nashik-Gonde section of NH-3.
- As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-3. 33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
