Sub: Four laning of Goa-Karnataka Border to Kundapur section of NH-66 (formerly NH-17) from Km. 93.700 to Km. 283.300 in the State of Karnataka to be executed as BOT Project on DBFO Pattern under NHDP-IV: Proposal for laying water supply pipeline parallel & Crossing to NH-66 from Panjim to Mangalore road at several lovations between Km.108+560 to Km.133+810 of NH-66 in Karwar-Ankola town under providing dedicated water supply scheme(21.0MLD) to seabird, Naval Base, Karwar in the state of Karnataka.
