The Executive Engineer, NH Division, Chitradurga has submitted the proposal of M/s. BPCL, abutting on LHS of NH-206 (Tumkur - Honnavar section) at Km 215.044 in Sy no. 3/1 of Malligenahalli Village, Shimoga taluk & District, Karnataka State, vide letter cited under reference above (Annexure I) to this office. The proposal is examined and observed that, the gap in the central median from fuel station (for divided carriageway only) is at 107m as against minimum of 300m as per Ministry Guidelines issued vide letter No.RW/NH-33023/19/99-DO.III dated 24.07.2013. As per Clause 4.5.3 read with Clause 4.5.2 B(i) Urban Stretches, the median gaps in proximity of intersections, the provisions stipulated under para 4.5.1 & 4.5.2 shall apply. In the present proposal, the location is Urban Area with more than 1.00 Lakh population (Population of Shimoga CMC is 3,22,650). Hence, the minimum distance as per Clause 4.5.2 B(i) is 100m. Justification is enclosed as Annexure - II.

- As per Ministry vide OM No.RW/NH/33023/19/99-DO.III dated 16.03.2016, the Highway Administrator will make available in the Ministry's website (morth.nic.in) the relaxation proposal w.r.t the distance of gap in the median opening for public comments, and the comments shall be invited within 60 days from the day of uploading.
- In view of the above, the comments from public on the above mentioned proposal w.r.t the distance of gap in the median opening is invited as per Form-A (copy enclosed) to the below mentioned address:

With reference to the above subject, the applicant Bharat Petroleum Corporation LTD, Mangalore, under ref(2) has applied for permission for installation of New Proposed MS/HSD retail outlet abutting on the Left side boundary of NH-206 (Tumkur – Honnavara Section) at Km. 215.044 in Sy No. 3/1 of Malligehalli village, (Shimoga city limit) in the taluk of Shimoga, Shimoga District, Karnataka State.

The Assistant Executive Engineer, National Highway Sub Division, Shimoga has inspected the site on 01-08-2019 and reported vide in ref(1) as under:-

- The site of the Proposed Retail outlet is on the Existing Four Lane with divided Carriage way with paved shoulder on Left side of NH-206 (Tumkur-Honnavar Section) at Km 215.044 in survey no: 3/1 of Malligenahalli village, Shimoga taluk, Shimoga district, Karnataka State.
- 2. The proposed site location at Malligenahalli village lies under the Shimoga city limit. Hence, the above site location falls under the non urban area (Rural stretch) as per MoRT&H Norms.
- 3. Frontage of the site is 35.00 Mtrs.
- 4. The building line is maintained at a distance of 32 Mtrs from the center line of the National Highway as per the Urban stetch.
- 5. There is a median opening at a distance of 107 mtrs towards Tumkur side and 247 mtrs towards Honnavar Side
- 6. There are no fuel stations within a distance of 300 mtrs from the proposed site on either side of the National Highway satisfying the MoRT&H requirements.
- 7. There is no railway level crossing with in 200mtrs from the propose site on either side of the National Highway satisfying the MoRT&H requirements,

- 8. There is no ROB within 200 mtrs from the propose site on either side of the National Highway satisfying the MoRT&H requirements,
- 9. There is no Grade separator/Ramp within 200 mtrs from the proposed site on either side of the National Highway satisfying the MoRT&H requirements,
- 10. No check barriers/Toll plaza on either side of the proposed site up to a distance of 1000.00 Mtrs.
- 11. All the standard conditions have been specified as per MoRT&H guidelines.
