The proposal is regarding permission sought by M/s. Torrent Gas Private Limited will lay below the utility by HDD method maintaining a safe distance of 500-1000mm and wherever other utility is going parallel, M/s. Torrent Gas Private Limited will lay below the utility by Open cut method maintain a safe distance of 500mm.
