Sub: NHAI - PIU - Puducherry - Four laning of Sattanathapuram (Km.123/800) to Nagapattinam (Km.179/555) Section of NH-45A on HAM under NHDP Phase-IV in the state of Tamil Nadu - Laying of Natural Gas Pipeline along NH-45A between Thittacheri to Panangudi in Nagapattinam District chainages from 167/710 to 170/180 (RHS) viz., laying of Natural Gas Pipeline along the road on RHS from Km 167/710 to Km 168/150 for a length of 440 meters and laying of Natural Gas Pipeline along the road on RHS from Km 168/830 to Km 170/180 for a length of 1350 meters totalling 1790 metres and crossing at Km 170/180 on National Highways in the state of Tamil Nadu - **Invitation of Public Comments** - Reg.

The proposal is regarding permission sought by M/s. Torrent Gas Private Limited for laying of Natural Gas Pipeline along NH-45A between Thittacheri to Panangudi in Nagapattinam District chainages from 167/710 to 170/180 (RHS) viz., laying of Natural Gas Pipeline along the road on RHS from Km 167/710 to Km 168/150 for a length of 440 meters and laying of Natural Gas Pipeline along the road on RHS from Km 168/830 to Km 170/180 for a length of 1350 meters totalling 1790 metres and crossing at Km 170/180 on National Highways in the state of Tamil Nadu submitted to this office by M/s. Torrent Gas Private Limited letter No. TGPL/Karaikal/NHAI/2021-22/218 dated 12.01.2022.

2. M/s. Torrent Gas Private Limited has proposed to laying of Natural Gas Pipeline for a length of 1.790km (from km 167/710 to km 170/180).

3. M/s. Torrent Gas Private Limited has proposed to lay of Natural Gas Pipeline along the National Highways, wherever other utility crossing is there below 2.5 to 3.0 m, M/s. Torrent Gas Private Limited will lay below the utility by HDD method maintaining a safe distance of 500-1000mm and wherever other utility is going parallel, M/s. Torrent Gas

Private Limited will lay below the utility by Open cut method maintain a safe distance of 500mm.

4. The submitted proposal is in conformity with Ministry's latest guidelines, regarding accommodation of public and industrial utility services along and across National Highways, issued vide letter dated 22.11.2016.


5. M/s. Torrent Gas Private Limited has furnished an undertaking for shifting of the pipeline at their cost during future widening of the above road.

6. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Torrent Gas Private Limited will be made available for 30 days for public comments/objections and the comments are to be furnished within 30 days from the day of closure.
