**Sub.: NHAI-PIU-NSK- Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the state of Maharashtra - Proposal for laying 800 mm dia & 1000mm dia Sewer Pipe Line along NH-3 on from Km. 308/700 to Km. 309/600 & 310/400 to 311/800 along NH-3 in Malegaon City - Reg.**

Municipal Commissioner, Malegaon Municipal Corporation vide letter cited above, has submitted the Proposal for laying 800 mm dia. & 1000 mm dia. Sewer Pipe Line along NH-3 (Dhule-Pimpalgaon) Section of NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying 800 mm dia. & 1000 mm dia. Sewer Pipe Line is proposed along NH-3 (Dhule-Pimpalgaon) Section from Km. 308/700 to Km. 309/600 & Km. 310/400 to Km. 311/800 along NH-3.

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R (R), Dtd. 22.11.2016, the Highway Administration shall be put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
