  - ii. Jeevan Jyoti Kala Kendra in JV with Sugam International Sansthan

While evaluating the Technical Proposals of the Consultants/NGOs it was found that the proposed experts by Jeevan Jyoti Kala Kendra in JV with Sugam International Sansthan are not exclusively available for the project. Thus the proposal of Jeevan Jyoti Kala Kendra in JV with Sugam International was not evaluated.
