Proposals are hereby invited from eligible Project Management Consultancy (PMC) firms for preparation of Detailed Project Report, Pre construction activity and Project supervision during construction as well as maintenance period for the work of "Project Management Consultancy services for Widening to 4-lane of NH-105 from Km 35/00 to 66/275 of Nalagarh to Swarghat road in the State of Himachal Pradesh".
