- **6.** The bidder should ensure safe loading/unloading/transportation and placing of assets of this Office to the destined place and the work assigned should be accomplished within the time frame as settled.
- 7. The bill for payment in duplicate should be submitted alongwith certificate in respect of completion of shifting/placing of Assets in the manner as prescribed

and time frame obtained from the Officer concerned.

8. The assigned work should be completed within a period of two days from the date of placement of the contract. In case of non-completion of assignment within the stipulated time or any damage caused to the Govt. property/records, no payment shall be made. An Indemnity Bond to this effect is to be furnished by all the bidders alongwith the tenders.
