Sir,

This has reference to the letter mentioned above vide which BSNL-proposal for laying of underground OFC from Chowka TE to Fadlugora TE 24F route along the NH-33 from Km 213.800 to Km 243.700 (30 Km approx.) has been forwarded. The said proposal was has been examined by IE of subjected stretch and following observations/clarifications have been raised:

(I) Sr. no 1.8 (b): BSNL will lay the OFC in RHS at the width of 20.5mtr, but at same location Bus lay bay, Truck lay bay and Toll plaza is proposed. Hence at these location laying of OFC at 20.5mtr is not considerable. (II) Sr. no. 1.15(ii): At Chowka km 213+800 to Km 214+740 required width for construction of road is 23mtr each side and nence at this location laying of OFC at width of 20.5mtr is not considerable.

(III) Sr. no. 2: Drawing enclosed is not proper, the ROW showing in the drawing is at 21.5mtr, 21mtr. 22Mtr, 20.5mtr. But actual ROW from ECL is 22.5 mtr. Also in drawing the diameter of pipe which is to be laid is not showing.

In drawing where structure is proposed or in old existing structure, there is no any provision of utility is (iv) crossing via duct, but in submitted drawing it has been shown that BSNL will cross the OFC via duct at the top of the slab, so it is not considerable. Hence at the structure the utility should be provide via bracket.

In view of above, the said proposal of BSNL is recommended with a condition that before signing of Agreement BSNL will comply the above observations mentioned above.

With reference to the aforesaid subject and references, kindly find herewith the required compliance point wise as noted below,

- 1. For SI No-1.8 (b)- The laying of the BSNL OFC in RHS at a distance of 20.5 mtr was a proposal only. The BSNL will consult the site engineer of NHAI during the execution of work and laying will be carried out as per the instruction of NHAI officials only. The BSNL cable will be laid at the extreme edge of the available ROW offset or as instructed by NHAI, where there is proposal of Bus lay Bay, Truck lay Bay and Toll plaza.
- 2. SI No. 1.15 (ii) At Chowka (213+800), the BSNL OFC cable will be laid at the extreme edge of available ROW or as instructed by NHAI by HDD method (No Dig method) at a minimum depth of 1.65m from road surface.
- 3. Sl No-2- The ROW offset in the drawing has been shown at a different distance differently because it is as seen on site and if the actual ROW offset is of 22.5m then the OFC will be laid at the 22.5m only or as per instruction of NHAI officials. The diameter of the BSNL PLB pipe will be 40 mm.
- 4. At the structure, the BSNL will lay the OFC by providing Bracket/clamp.

The BSNL will comply the rule and regulations of NHAI while executing the work, Therefore, it is requested to accord the ROW permission at the earliest.
