Sub: Proposal for grant of access permission to the proposed new retail outlet by M/s IOCL at Km 119/805-840 RHS (Survey No.98/1) of Pasarlapudi-Dindi section of NH-216 at Razole village in Razole Mandal in East Godavari District in the state of Andhra Pradesh.

The Deputy General Manager (RS), Visakhapatnam has informed about the proposal of new retail outlet of M/s IOCL in the subject mentioned project and requested this office for grant of NOC with relaxation against the norm "distance of intersection with any category of roads of carriageway width 3.5m and above and the same with width less than 3.5m". The distances are 24m and 13m against MoRTH norms of 300m and 100m respectively. The applicant has sought relaxation from Ministry's guidelines issued vide letter no. RW-NH-33023/19/99-DO-III dt.24.07.2013 based on justification at Annexure I.

2. As per the Ministry vide OM No.RW/NH/33023/19/99-DO.III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60days from the day of uploading.


