The proposal is seeking permission for laying Underground Water Supply pipe line along the road between Km.280/570 and Km.280/950 on NH-544 (Thrissur to Angamali Section) in the state of Kerala by Kerala Water Authority submitted to this office vide PD,NHAI, Palakkad's letter No. NHAI/PD/Palakkad/NH47/T-A/KWA Pipeline/ dated 07.03.2019 in accordance with Ministry's latest guidelines dated 22.11.2016.

This is in regard to granting of permission to Kerala Water Authority Nattika for laying of underground water supply pipe line between Km. 280+570 and Km. 280+950 for a total length of 0.460 Kms alongside NH 544 in the Four lane stretch of Thrissur to Edappally.

The Executive Engineer KWA Nattika vide reference (2) cited above has submitted the proposal along with drawings to this office as per Ministry Guidelines vide reference (3) cited above. Accordingly, the proposal has been examined by this office. KWA has proposed to lay the water pipe line in various diameters through open trench method and HDD method as detailed below:
