Sub: - Permission for laying D1 pipe line for gravity pumping main of " Bulk water supply project for IIT, Bhubaneswar, National Institute of Science, Education and Research (NISER), Infocity-II and adjoining area on Public private partnership (PPP) mode on DBFOT basis in the state of Odisha.

Sir,

In inviting a kind reference to the subject cited above and your letter under reference it is to state that the laying of the pipe line from 296/500 to 296/665 km of NH-57, where the existing ROW is 8 Mtr have been proposed under the drain so that there will be no hindrances to the existing carriageway.

As regards the carriageway reported in the ROW statement and pointed out in your above letter are measured at the site by the Assistant Engineer and Assistant Executive Engineer of P.H. wing in presence of Assistant Engineer, N.H. Section, Khordha and found as noted below:-

As seen from above, it is suggested that the pipe line may be laid under the drain at the chainage from i.e 297/100 to 297/700 where the ROW is 8 mtr keeping the existing carriageway undisturbed as per the Ministry guideline.

Hence the observation as mentioned in the letter cited above is complied herewith.
