Invitation of public comments

**Sub.: Proposal for final formal permission and signing of license deed for access to the fuel station of M/s Hindustan Petroleum Corporation Limited in Km.321 (Ch.320.858, RHS) on NH-76 (New NH-35), Village Jorwara, Tehsil Mau & District Chitrakoot in the State of Uttar Pradesh - Reg.**

The provisional NOC for the instant retail outlet was granted vide this office letter no. RO/LKO/HA/76/105/2014/2015 dated 26.11.2014 with the condition that "in case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority". However, it is seen that the case has been submitted after the elapse of said deadline. Thus, it is seen that that there is delay in construction of the instant retail outlet and involves deviation from the Ministry's extant guidelines.

2. The Oil Company M/s Hindustan Petroleum Corporation Limited has submitted justifications for the delay, wherein it is mentioned that NOC from District Magistrate was granted to M/s Hindustan Petroleum Corporation Limited on 28.05.2018 i.e. around 3 years 6 months after the provisional NOC was issued. This resulted in delay in construction work at fuel station. Thus, applicant could not start the work immediately on the site in absence of these statutory approvals as budget is approved only when all the statutory approvals are in hand. Construction work has been completed on 10.11.2019 i.e. the proposal was submitted after the elapsed deadline of provisional NOC period.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).

4. In view of the above, comments of the public on the above relaxation proposal because of non-fulfillment of completion of the criteria of construction with stipulated time-period, is invited to the below mentioned address:
