INVITATION OF PUBLIC COMMENTS

Sub: NHAI, Madurai Region - PIU, Madurai - Operation and Maintenance of Madurai - Kanyakumari section from Km.0/000 to Km.243/170 of NH-7 in the State of the road at Km.240/940 to Km.241/190 (RHS) of Madurai - Kanyakumari section of NH-7 in S.No.195/1 & 197/1 of Agasteeswaram Village, Kanyakumari District - Proposal submitted - Reg.

The proposal is regarding permission for laying water supply pipeline along NH from Km.240/940 to Km.241/190 (RHS) in Madurai - Kanyakumari section of NH-7 in NHAI/MDU/NH-7/Utility/2020/2449, dt.10.10.2020 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The proposal made by the applicant Shri. M.T. Arunan, Chennai is for laying water supply pipeline along the road from Km.240/940 to Km.241/190 (RHS) in Agasteeswaram village in the section of Madurai - Kanyakumari of NH-7 in the State of Tamil Nadu i.e. in a length of 250m at the extreme edge of RoW as detailed under:

- 3. The Right of Way is 60 m in the aforesaid stretch. The proposed water supply pipeline along the road from Km.240/940 to Km.241/190 (RHS) for a length of 250m. Further, the applicant Shri. M.T. Arunan, Chennai has given undertaking that the supply pipeline is proposed to be laid by *Trench Method* at a depth of 1.7m distance to the pipe from the top of the sub grade at the extreme edge of RoW which is in conformity with Ministry's latest guidelines dated 22.11.2016.
- 4. The applicant has furnished an undertaking that they will shift the laid water supply pipeline in future when required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, design, stability, traffic safety and future improvement of the proposed stretch.
