Invitation of Public Commets

Sub:- Issue of access permission for construction of an approach road to the proposed new Petrol/diesel retail outlet in survey No.146/3 of Muringoor Thekkumuri Village, Koratti, Mukundapuram Taluk, Thrissur District at Km.299/068(LHS) on NH-17 (New NH-544) of Kerala State by M/s Essar Oil Ltd-reg.

This office vide letter dated 29.03.2016 (Annexure-I) has accorded provisional NOC for construction of access to the above mentioned Retail Outlet with a condition to complete the construction as per approved drawings and furnish the Completion Certificate from the field authority within one year from the date of issue of provisional NOC. Further, owner of the Retail Outlet (M/s Essar Oil Ltd) vide letter dated 04.04.2018 has sought one year extension for completion of the construction work. Based on the details furnished by M/s Essar Oil Ltd, this office has accorded the extension of time for construction of access to Retail Outlet up to 28.03.2018(Annexure-II)vide this office letter of even number dated;11.05.2018.

- 2. Now, the applicant M/s Essar Oil Ltd., vide letter dated 03.09.2018 (Annexure-III) addressed to this office has sought further extension of time for constructing the access to the above mentioned Retail Outlet up to 26.02.2019 due to the delay in obtaining permission to the retail outlet from other State Departments and scarcity of materials and labour for construction.
- 3. Since the extension of time sought is nearly 2 years from the issue of provisional NOC, the proposal comes under relaxation category with regard to the non-compliance of timeframe for the construction of access to the above Retail Outlet. As per the guidelines issued by the Ministry vide O.M. No.RW/NH-33023/19/99-DO III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments and the comments will be invited within 60 days from the day of uploading in the format enclosed as Form 'A'.
- 4. In view of the above, comments of the public on the above relaxation proposal is invited to the below mentioned address:


