The Roads and Building Department, Government of Gujarat vide letter no. The BG should be in favor of the Executive Engineer, NH- Division, Gandhidham (as per prevailing procedure in R&B Dept.) and to be submitted to Executive Engineer, NH- Division, Gandhidham custodian of BG/s.
